March 15th The Bucerius Institute (BI) hosted **Dr. Herbert Lappe** from the Jewish community in Dresden. Dr. Lappe spoke about **The Holocaust Remembrance in East Germany (GDR)**. In his lecture Dr. Lappe examined the inconsistently of the memory of the Holocaust in the communist East Germany. On the one part it was well known, but on the other part people knew nearly nothing about Jews, history of the Jews in Germany and the background of Antisemitism. Furthermore Dr. Lappe emphasized that the GDR narrative was focusing on Germans as victims of the Nazis rather than on being co-perpetrator of their crimes.

March 16th A workshop reflecting the Israeli NGO bill and its possible impact on the work of foreign NGOs in Israel was held at the University of Haifa. This workshop was part of a cooperation with the HCGES and the Ruhr University of Bochum. The workshop was conducted by our PhD student **Katharina Konarek**.



March 17th **Prof. Derek Penslar** (University of Oxford and Toronto) gave a lecture on **“Theodor Herzl, Race and Empire”**. Prof. Penslar showed that Herzl was deeply imbedded in fin de siècle colonial and racial discourse. He also discovered in Herzl a complex blend of sympathy and antipathy towards colonized people, and a stark difference between Herzl’s views of the Orient and Africa.



March 31st **Dr. Giacomo Petrarca** (University Vita-Salute San Raffaele – Milan) talked about **“The concept of silence in Franz Rosenzweig and Henri Bergson: a comparison.”** In his lecture Dr. Petrarca analyzed the difference between the rosenz-weighian vision of silence and the bergsonian conception of silence. He put a special focus on the *Essay on the immediate data of conscience* (*Essai sur les données immédiates de la conscience*, 1889) and on other texts in which Bergson (1859-1941) considers the problem of silence related to the limits of language.



April 14th the BI hosted the historian **Mr. Doron Arazi** who spoke about: **“Ostracism, Acceptance, Admiration: German Brands in Israel between Holocaust Memory and Consumer Pragmatism, 1929-2016”**. In his lecture Mr. Arazi gave an overview of the development of the German-Israeli trade relations.

It dealt with the questions: What role do the German political foundations play in the international arena? What impact do they have on the German foreign policy? Are they think tanks, independent political actors or an instrument of the foreign office? How do they influence the political landscape in the countries, they are working in? How did and do they influence the development of German-Israeli relations? Israeli, German and Palestinian academics and experts from the field discussed these questions intensely. The main contributions will be published in a conference volume.

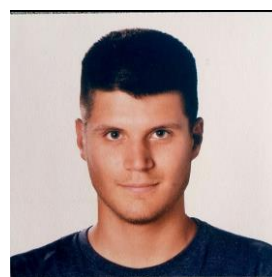
June 16th **Dr. Angelika Timm** (Berlin) presented her research on the topic:

The institute congratulates Mr. **Micha Limor** for beginning his PhD. about the German Bet-El Community in Israel – “The New Templars”.

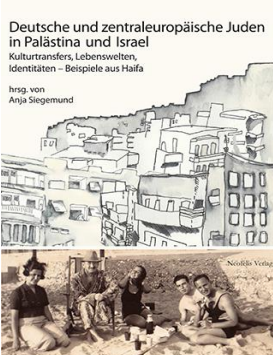
June 16th In the framework of the Departmental Seminar of the Department of Jewish History,
